This person is an apparent fraud - he is not a White Bluff Property Owner and, in fact, no such public record of that name can be located or verified. The return address (P.O. Box 1039, Fort Worth) is that of a Texas gubernatorial candidate.

Your mailing addresses were apparently obtained by searching and copying from the Hill County Central Appraisal District data base - check one of your recent tax statements.

When Dan Saturn may have revealed, that R. Mike Ward and his cronies at White Bluff, clearly broke the law. It would be easy to go to the Post Office (or US Postal Inspectors web site), and file a complaint about a False Bill or Notice for Taxes (or Property Owners Association fees), from R. Mike Ward's employees at 5495 Beit Line Road, Suite 200, Dallas, Texas 75254. You might send a complaint to Greg Abbott at PO Box 12548, Austin, TX 78711-2545. But, it might be better, to send a letter about your plight, to Greg's Wife, Cecilia Abbott, at PO Box 308, Austin, TX 78701.

In a letter dated December 31st, 2013, Mitt Bergman announced a special assessment for legal fees, after the regular November Board meeting, by Chairman R. Mike Ward and his 3 fellow Board members. This assessment wasn't mentioned before the meeting in the agenda, or even considered during the meeting, in violation of Sec. 209.0051 (e) and (h) (6) of the Texas Property Code.

This crime was called extortion, but is now consolidated with other thefts in Sec. 31.03 of the Texas Penal Code as appropriation of property without effective consent. This means that they took your money by sending you a bill which falsely implied, that they had legal authority to make you pay their legal fees. R. Mike Ward and his accomplices illegally billed you and the other owners, for nearly \$300,000. See the documents at FreeWhiteBluff.com, What happened in the past, 2013, Nov 18th and Dec 31st. Take this card to your local police, sheriff, County Attorney, or Prosecutor and file a complaint. The scope of this crime is so large, your local law enforcement may ask for help from the Texas Rangers.
